## SA AUSTSWIM Swimming and Water Safety School of the Year Award

### Tips and Hints for Completing Application

- Nominations must be submitted on the official AUSTSWIM Award Nomination Form. Applications not on the official nomination form cannot be considered.
- Nominations must include detailed information that directly addresses the selection criteria. Nominations should provide suitable examples to demonstrate the nominees breadth and depth of skills, experience and knowledge.
- Nominations that do not address the criteria or are in contravention of AUSTSWIM Guidelines for Teaching Swimming and Water Safety &/or Code of Behaviour and Objectives and guidelines associated with the AUSTSWIM Swim School Recognition Scheme will not be considered.
- Applications should be restricted to a maximum of 7 pages (excluding references), typed in font Arial, 11-point.
- Additional supporting material should be attached to the application e.g. certificates, brochures.
- Nominators should not assume that the awards committee knows the organisation.
- All nominations (nominees) will be notified in writing of the results.
- Winners of this state award will be nominated to AUSTSWIM for the AUSTSWIM National Award in the same category.
- Queries should be addressed to AUSTSWIM on 1300 885 666.

### General Guidelines

- The appropriate awards committee will consider all nominations and rank nominations in accordance with the information included in the application and the two (2) written references. Nominations must address all criteria and clear, substantiated examples for each.
- The nomination should reflect the organisations involvement in, understanding of and compliance with AUSTSWIM's code of behavior, objectives and guidelines for teaching swimming and water safety including the guidelines associated with the AUSTSWIM Swim School Recognition Scheme.
- To be eligible for an award the organisation must be able to demonstrate considerable experience and/or knowledge in all areas of the selection criteria and be registered as part of the AUSTSWIM Swim School Recognition Scheme.
- It is recommended that nominators seek information from the nominee regarding the accuracy and veracity of claims. The committee may decide to check personally with either or both referees.
- Information, photographs and material provided in the nomination may be used by AUSTSWIM at anytime for promotional, marketing purposes.
